Call For Artists

Shore Arts Center invites submissions for the 49th annual Autumn Art Show. Accepted entries will be on display from October 25th to October 28th. An opening reception will be held from 6-9 pm on October 25, 2018. The reception is free and open to the public. Wine, beer and cheese will be served and the People's Choice voting will be held from 6-7:30pm. The awards presentation will begin at 8pm. All artists are invited and encouraged to enter and attend. There will be divisions for adults and students. The following awards will receive cash prizes in each age division: Best of Show, People's Choice, Area Attractions, and the Southeast Colorado Arts Council/Anne Boken Trust Award. The judge for the show will be Susan Touchstone.

Online Pre-Registration opens September 25, 2018. ALL Artwork, Entry Fees, and Late Registrations will be accepted on October 20st from 2-5pm and on Sunday October 21st from 2-5pm at the Shore Arts Center, 115 Main Street, Lamar, CO.

Cash Prizes and Ribbons

Adult Division: Best of Show \$400, People's Choice \$200, Area Attraction \$200, and Southeast Colorado Arts Council/Anne Boken Trust Award \$200

High School - SR Division: Best of Show \$50, People's Choice \$25, Area Attraction \$25, and Southeast Colorado Arts Council/Anne Boken Trust Award \$25

Elementary - JR Division: Best of Show \$25, People's Choice \$15, Area Attraction \$15, and Southeast Colorado Arts Council/Anne Boken Trust Award \$15

First, Second, Third, and Honorable Mention certificates will be awarded in each category also.

Media Accepted: Watercolor, Acrylic, Oil, Graphite, Ink, Mixed Media, Photography, Colored Pencil, Digital/Graphic Art, Sculpture, Collage, Fiber Arts, and Artisan Crafts.

Size: Artworks cannot be larger than 4ft wide and 8ft tall unless special arrangements are made.

Style: All artistic styles are welcome.

Subject Matter: All subject matter welcome.

Delivery: Costs of shipping artwork and/or delivering artwork to and from Shore Arts Center is the sole responsibility of the artist. If the artwork does not sell, it is the responsibility of the artist to pick up the artwork by 5pm on Sunday, October 28, 2018. Any artwork that is left after this date and time will become the property of AVWPE, Inc. and used to fund future shows. No exceptions as this has been a problem in previous shows.

Display: All artwork MUST be wired and/or properly prepared for hanging. Works that do not fit this criteria will not be accepted.

Insurance: The Shore Arts Center does NOT provide insurance for artwork. If the artist would like to insure their artwork during transit and exhibition, they must do so themselves.

Pricing: All artworks must be available for sale with prices clearly labeled on the registration form(s) OR clearly marked NFS (Not For Sale). Artists will be informed immediately when sales are made either by phone or email. The Shore Arts Center takes a 25% commission on sales, which the artist must factor into their pricing at time of registration. By participating in this exhibition, the artist agrees to allow the Shore Arts Center to negotiate up to 10% from their submitted price to facilitate sales.

Submitting Information: Artists cannot change details or information on their registration submissions after the deadline for entries has passed. Exhibition labels, show lists, and online information are generated from the information provided at the time of registration. Please verify your submission information and ensure that it is correct BEFORE turning it in.

HOW TO ENTER: This show is open to all artists and includes an Elementary JR division for children ages 5-12, a Middle/High School SR division for students ages 13-18, and an Adult division for anyone 19 and older. We encourage all artists to pre-register online by filling out the submission form found at www.avwpe.org/autumn-art-show and then the registered artwork must be delivered to Shore Arts Center at the registration times found above. Payment must accompany the artwork and is due prior to work being accepted. Entry Fees: The entry fee is \$35/adult artist and is non-refundable. Artists can submit up to 10 entries. Children/Student entries are free and are limited to 3 entries per person.

Conditions: Submission of entry to this exhibition automatically constitutes the entrant's acceptance of the guidelines and rules outlined in this Call for Artists. Due to the volume of entries, Shore Arts Center nor our judge will provide individual feedback on submissions. The judge's decisions are final. *Information within this prospectus, including prizes, is subject to change and is at the discretion of the Shore Arts Center.
